I, the undersigned, herein referred to as the sailor have inspected the sailboat I am hiring and agree that other than any part(s) of it listed on the attached sheet the boat has no damage or missing parts. I also agree to the all terms and conditions applicable to the hire as stated overleaf.

The following are the terms and conditions of hire applicable to all sailboat rentals and forming part of this contract:-

1. Sailboats will only be hired to capable persons (the sailor) who already know how to safely and properly sail the class of boat they wish to hire without any third party assistance. Our sailboats are not toys and need to be treated with the same care, respect and responsibility you would be expected to show when hiring a motor vehicle.
2. In event it is determined by VCYC or any of their members after the rental period has commenced that the sailor is not capable of safely and properly sailing the class of boat they have hired without third party assistance the hire will be terminated forthwith, the sailor will not be entitled to any form of refund and still remain liable for any damage caused to the boat.
3. The sailor is completely and solely responsible for any damage of any nature whatsoever sustained to the sailboat or any part thereof during the rental period irrespective of how and by whom this damage was caused and will pay the full cost of reinstating the boat to its original condition.
4. Depending on the class of boat hired a damage deposit may be requested at the commencement of the rental period. Sailors who are not permanent Vanuatu residents are required to lodge a credit card as security to cover the cost of any damage and/or loss to the sailboat whilst in their care.
5. The sailor is responsible for rigging, launching, sailing, landing, de-rigging and washing down the boat they hire themselves and the time taken by them to do this will form part of the rental period. Limited assistance rigging, launching and landing the hired boat may be provided by VCYC but is not guaranteed to always be available.
6. The sailboat may not be 'beached' and when not been sailed the sailboat must be secured onto its launch trailer.
7. Suitable buoyancy aids must be worn at all times by all persons when sailing the boat. Use of approved buoyancy aids are available free of charge for the duration of rental period.
8. The sailor is responsible for their own safety as well as the safety of all other persons in their party and all others at all times during the rental period.
9. Use of the hired sailboat by the sailor and any other persons during the hire period is entirely at the sailor's risk. VCYC do not accept any form of liability for damage, injuries or any other event whatsoever whether caused by the sailor or not during the hire period and any such liability shall be that of the sailor and by entering this agreement the sailor agrees to waive any and all right they and any other person may have to seek any form of recourse from VCYC or any other person associated with VCYC arising from anything whatsoever before, during and after the hire period.

The VCYC reserves the right to refuse participation should a participant not sign this declaration.

PARTICIPANT DECLARATION

In respect to the VCYC activity. I am currently fit to participate in the VCYC programs and do not suffer from an illness, ailment or incapacity that may prevent me participating.

1. *I warrant that I understand that:*

- The VCYC will rely on this declaration.*
- The VCYC (to the extent permissible by law) will not be responsible for any loss, damage or injury arising from any pre-existing medical or psychological condition.*
- If I disobey any safety instructions given to me by the VCYC and as a result of disobeying those instructions, I suffer loss, damage or injury, I will not hold the VCYC liable.*
- I will be participating in this and any other VCYC program entirely at my own risk.*

2. *I hereby release and discharge the VCYC and its servants and agents to the extent permitted by law, from all claims which I now or at any time have, or but for this declaration, could or might have against the VCYC and their servants and agents in connection with or incidental to my participation in their program(s) or the circumstances recited in this declaration.*

3. *I hereby guarantee and agree to hold the VCYC and their servants and agents, to the extent permitted by law, harmless and indemnified against all claims which have arisen or may arise in respect of my participation in their program(s) or in any way connected with or arising from, by or on behalf of any person claiming under or by virtue of me.*

4. *I acknowledge that for the purpose of this declaration "Claims" means actions, demands, suits, causes of action, debts due, costs and expenses and other liabilities of any nature whether present, future or contingent including but not limited to a claim arising from a negligent act or omission.*
